Welcome to the KNA online nomination system. Please ensure you read this information before proceeding to the online nomination page.

NNSW Court Craft Summer Series

KNA is now calling for Player Nominations for the 2024 Court Craft Summer Series Competition.

The Summer Series is made up of 6 x Opens Divisions. KNA has previously entered 3 to 4 teams dependent on nominations.

Summer Series dates

- Round 1: week commencing, 14 October 2024
- Round 2: week commencing, 21 October 2024
- Round 3: week commencing, 28 October 2024
- Round 4: week commencing, 4 November 2024
- Round 5: week commencing, 11 November 2024
- Round 6: week commencing, 18 November 2024
- Round 7: week commencing, 25 November 2024
- Round 8: week commencing, 2 December 2024
- Round 9: week commencing, 9 December 2024

Summer Series format

- Summer Series will be played across 9 rounds/ 9 weeks.
- All teams will play each team in their division once.
- The Winner and Runner up in each division will be determined by first past the post.
- All matches will be centrally timed.
- Matches will be played at 6.30pm, 7.40pm & 8.50pm, due to court allocations timeslots may not always alternate each week.

Summer Series Divisions and playing nights

- 6 x Divisions of Opens
- Maximum 10 teams per division
- Minimum age – turning 15 years in the year of play
- Division 4,5 & 6 - Tuesday night
- Division 1, 2 & 3 – Thursday night

KNA Mission Statement

To continually develop KNA as a premier netball association through the provision of leading edge representative programs, which develops talent, fosters teamwork and encourages the pursuit of personal and team excellence.

Selection Information

Selectors

The Senior Rep Selection Convener along with Senior Selectors will form the selection panel. The team coach/s will also be part of the selection panel if appointed prior to selections.

Conflict of Interest

Should any of the selectors have a relative who is trialing this constitutes a conflict of interest, and accordingly they will not participate in any discussions or vote concerning their respective relative's position in a team.

Selection Information

- The Senior Selection Panel will determine the appropriate competitions KNA will enter teams into based on nominations and team balance. Teams for Summer Series are paper graded and trials will only be held if required.
- The team selections for this series will be based on performances this season at Premier League, Metro League and during the 2024 rep season (for the current 15 year players).
- Any player who nominates and has not played in the current years Metro League competition, will be paper graded based on their 2024 grade and previous playing experience.
- Team balance will also be considered when making selections to ensure that each position has suitable coverage.
- KNA has a player "loyalty" policy for all teams. Whilst KNA is willing to accept players from other Districts, such selection will be dependent upon the standard of those players as compared to the current KNA players and the team balance. Preference will always be given to current KNA players in circumstances whereby the players are judged to be equal in ability.
- Players who accept a team offer and then chose to trial at other Districts or do not withdraw from positions already obtained at other districts will have their accepted status changed to under review.
- Playing in the 2024 Summer Series competition **does not** guarantee selection into a Metro League team the following season. Playing in previous year/s Metro League, Summer Series, State Championships or Representative season competitions does not guarantee selection into a team.
- At this stage we cannot confirm the number of teams or divisions that will be entered in the 2024 competition until all nominations are received.

Notification

All players will be advised by email of the outcome (ie; team offer or non-selection) following selection trials. All players must respond by acceptance (or otherwise) of their position including acknowledgement of the various commitments.

KNA Senior Representative Commitments 2024

The following conditions and commitments must be read and agreed on the nomination form for your application to be accepted. If you have any concerns or questions regarding selection issues please contact knasenioreps@kna.com.au.

KNA Player Mission Statement

To represent our Association and my team to the best of my ability and ensuring that the ideals of netball - participation, fitness, competition, teamwork and, above all, sportsmanship are always maintained.

You will be required to confirm that you have read and agree with the KNA Player Mission Statement on the nomination form

KNA Representative Commitments

Representative players not only make a commitment to KNA, but just as importantly they make a commitment to the rest of their team. Absences from training, games and any representative functions (other than those absences that cannot be avoided) are unfair to the team, KNA and those players who were not fortunate enough to be selected in a representative team.

It is expected that all KNA Senior Summer Series representative players meet the following commitments:-

- Attendance at each game. Players may be rostered off at the discretion of the Coach and need not attend on those days.
- Attendance at any training session called by the coach (training sessions are at the coach's discretion)
- Attendance at NNSW presentation ceremonies held following the Competition if Premiers or Runners up in your division.

Players unable to train/play for more than 1 week due to injury will need medical clearance to resume training and playing.

Failure to meet the above Representative Commitments may lead to the player being withdrawn from their representative team on the recommendation of the KNA Representative Selection Convenor and at the sole discretion of the KNA Representative Committee.

You will be required to confirm that you have read and agree to Representative Commitments on the nomination form.

Player Code of Behaviour

It should always be remembered that you are representing KNA at all times whilst playing matches, attending carnivals, and visiting other Associations. Netball NSW has a Code of Behaviour Policy <https://nsw.netball.com.au/sites/nsw/files/2022-03/Final%20CLEAN%20-%20NNSW%20Codes%20of%20Behaviours%20-%20091121.pdf> that we expect our players to adhere to, and any deviations from this conduct will not be accepted. Whilst we wish all players to really enjoy their representative experience, it is also important that we do so whilst respecting those around us. Failure to maintain the expected Player Code of Behaviour may lead to the player being withdrawn from their representative team on the recommendation of the KNA Representative Committee and at the discretion of the KNA Executive.

You will be required to confirm that you have read and agree to Players Code of Conduct on the nomination form.

Parent/Guardian/Spectator Code of Behaviour

It should always be remembered that you are representing KNA at all times and inappropriate comments or behaviour, verbal abuse or public criticism of players, coaches, umpires or officials will not be tolerated under any circumstances. Coaching from the sideline will not be tolerated. Cost of Program: all KNA players from Netta to A1 subsidize the cost of the Junior and Senior Representative program. All players in our representative programs both senior and junior are required to contribute towards these costs.

Player entry passes need to be purchased online and a link will be sent out in September. These passes are approximately \$50 for the season.
