• COVID 2022 – our Current Protocols will be updated and distributed on boards and to clubs.

NSW Health have changed the rules surrounding household isolation with positive contacts. If there is a positive household and other family members continue to test negative and display no symptoms, they are free to continue with a "normal" life. Positive household members are required to continue isolation for seven days from the date of the positive COVID test.

If you are displaying respiratory symptoms but are showing a "negative" RAT test, we would recommend that you do not attend training or competition games until you have a second negative RAT test 3 days later, or your respiratory symptoms start to resolve.
