CONFIRMATION MINUTES EXECUTIVE MEETING 28th May 2019:

Ros Roots moved, Loraine Unicomb second.

TREASURER:

Winter registration fees are below budget (budget based on 2018 registration fees). Registrations down overall, numbers reduced in NSG and Seniors.

Income from the BBQ and Canteen seems to be the same each week.

Bart will work with the Auditor to work out how to offset the building levy that has accrued over the past 10 years which has now been allocated for the lighting installation. Current thinking that we continue the Building Levy in the future with the proposed new complex and upgrades ongoing.

GENERAL BUSINESS:

- 1. North Turramurra and The Glade both handed over. Both sites are shared facility with removable posts that need placement daily by two persons, but they are very heavy to pull up and move. Will monitor this. KMC have been advised.
- 2. Strategic meetings of Office Bearers having meetings at the moment with their Committees for feedback on strategy points Some good feedback is coming through. Nothing will be dismissed from all the ideas coming in from the strategy meetings. Exec will pool all the ideas identifying most common.
- 3. Sister Clubs Feedback from Grading meeting. Raised idea that all Clubs with under 20 teams have an informal sister club arrangement between themselves. Main purpose is to be able to have smaller clubs borrow players from sister club still following the borrowing guidelines and approved by the Grading committee prior and possibly having aUniform provided by team/club borrowing the player/s.
- 4. E grade teams can be problematic as well in terms of who they can borrow from, very limited. to encourage playing for fun and participation. Grading Convenor will put together something for the President Forum and then formulate a policy for presentation at the AGM for member consideration.
- 5. NSG Lofberg start day suggest start season for NSG, 2 weeks earlier and have Umpire/Committee/Coaching/Executive representation during those first few weeks, and then hopefully support going forward.
- 6. Grading Strategy very interesting, good meeting. Loraine will distribute notes
- 7. Recommendation to Fixtures from Grading suggested Rotating the use of the top courts 1-4 where the E grade or lowest grade play on the top courts one week.
- 8. Build more of a community feel.
- 9. AGM venue Contact Corpus Christi Church for hall use. Rhonda suggested we possibly look at alternate venues. Nick check with North Turramurra Primary School. Check with Presidents on Sunday if they want to change the venue.
- 10. Our portable PA has broken, David investigating purchase of new one.
- 11. Grand Final Day We will invite Metro & NSU players to come along. David will handle Grounds on the day. Brenda send out invites to VIP, NNSW, Executive for attendance.
- 12. Volunteer of the Year Award –Exec to Suggest 2 or 3 for consideration (jo to facilitate
- 13. Grants update Jo-Anne recommended we contact NNSW to discuss the structure and format. They deal with state and federal government. Women in Sport Michelle McNamara mentioned Media Release about this. Loraine will follow up on this information.
- 14. President Forum –Agenda: Strategic Planning: Work shop– Executive. Small discussion groups to be established with a mix of small and big clubs. Loraine has the charts of paper, pens and stickers. Nick prepare some preliminary questions for consideration, perhaps 5 core points. "If you have a magic wand what would you do?" "What do we do well, what don't we do well?" Frame reference at the beginning we could frame this is a 5-10 year time frame. Can revisit after the forum one on one if needed.
