We have lost someone who is dear to our hearts - Jeanette Wright, whose dedication to the development of netball in our community is unsurpassed. Jeanette was one of KNA's founding members and continued to be an active member for over 50 years.

Jeanette was there in 1968 when Ku-ring-gai Netball Association came into being, she saw the Cannon Road courts open in 1979 and brought her four children, including her son Rob, to the courts every week. Indeed, Rob (current coach of Collingwood Magpies) has often credited his mother with his own passion for the game and his choice of career path: "I spent at least ten years when I was young watching mum coach club teams on a Saturday, as well as Representative teams on Sunday and that is where my interest in the game and coaching really started".

When asked in a newspaper interview what motivated her to volunteer, Jeanette's reply said it all, *"I just wanted to make sure that every little person who wants to play netball has that opportunity. Every kid – good bad and indifferent"*. Jeanette was a humble person whose impact on the many people she coached was enormous. The Regional Schools Competition that Jeanette initiated so many years ago still takes place at Cannon Road every Friday morning and many, now adult KNA members, owe their love of the game to her outstanding coaching and mentoring skills and her unwavering love of netball.

The legacy that Jeanette has left to our netball family is invaluable. She was co-founder of the West Pymble Netball Club and the strength and longevity of the club is a testament to her stewardship, guidance and dedication over the decades.

Her passion is irreplaceable. The hours of volunteering and service she gave cannot be calculated - and we do not have enough words to thank her for her commitment to KNA and the sport of Netball. The lives Jeanette touched are countless and the warm memories are many and never to be forgotten.

We are so proud to have known such a special lady. A lady who made us feel that we were all exceptional, a lady who was a giver of all things good.

RP Jeanette, our KNA family is better for having known you and our thoughts and prayers are with your family at this sad time.

2019 Competition season:

The few issues we had were handled very well in close consultation with our clubs and resolved amicably. Works:

Work has finally commenced on our Lights, together with additional works for our Physio shelter and general upgrades to our parking. This project should be completed by year end, so we can take advantage of the lighting for our 2020 Winter competition season. Only one night has been allocated for our Winter competition, but we have the joy of now having 9 more lit facilities for training. We just can't wait. Such exciting times ahead!

KNA members have approved our budget to do our lights and general works. We have been fortunate in having a fund- raising levy included in our registration costs. This was established over 10 years ago and is now assisting us to fund these projects. This levy is placed in a holding account to be used only for upgrades to our facilities and we thank our members for continuing the support of these projects.

On an exciting note, we were recently very privileged to be recipients of a grant for \$200,000 from the NSW Government "My Community Project" to help us fund our lights. This funding was allocated according to a public voting process by the Ku-ring-gai Electorate based on the Canoon Road courts locality, which made it even more special to receive and should be available for our next financial year through KMC facility at Canoon Road.

Our gratitude must go to Alister Henskens, State Member for Ku-ring-gai, who strongly supported us in achieving this goal. We thank him and our many members and friends in the Ku-ring-gai electorate who made this possible, by voting for us. It was a fabulous achievement, particularly as we have a membership base which is broader within the KNA community covering Davidson, Berowra and Hornsby electorates, so well done everyone on achieving this enviable goal.

6.5 Club Coaching Report:

We have had a busy 2019 with many coaching and player opportunities.

At the beginning the season our beginner coaches were given the opportunity to attend a Beginner Coaching Clinic with Lisa Duncan, KNA representative Coach and NSU Assistant coach, which proved extremely popular. This session focused on planning a training session and a demonstration of different drills used in each component of a training session. Over 40 club coaches attended this session. A big thank you to Lisa for presenting this clinic.

We have also had open training sessions available for all our club coaches throughout 2019. Thank you to our



KNA representative coaches for providing open sessions for coaches to attend. While numbers at these sessions are not high, coaches who do attend have commented on how beneficial the sessions are in terms of drills and planning.

In June we were given the opportunity to invite club coaches to an open training session with the Open and Under 23 North Shore United Premier league teams. A big thank you to NSU Head Coach Bec Bulley and Assistant Lisa Duncan from the Open's team and NSU Head Coach Colleen Mitchell from the Under 23 team for this opportunity. This was attended by approximately 15 club coaches from KNA and was a very beneficial experience for those who attended.

In August KNA hosted a Netball NSW Development Coaching Face to Face Course with 10 coaches achieving their Development level coaching qualification.

There been 4 player clinics run by NSU during 2019. These sessions are intended to enhance player skills in a fun environment. In terms of numbers the most popular was the Pre-Season Back to Netball Clinic with over 90 participants.

6.6 Fixtures Report:

This year we have successfully completed the fixtures for both KNA's Winter and Spring Competitions with minimal issues. For the winter competition we had adequate court space for all teams in all timeslots. We avoided the use of courts 20 & 21 which allowed for them to be used for warming up. We also avoided where possible the use of courts 17, 18 & 19 which do not have goal posts and are less popular with the teams. We again had short grades day on week 12 where for those in a competition of 6 teams, we played 2 half games. This ensured every team played each other 3 times. We created the fixtures for the NetSetGo Orientation Day, NetSetGo Gala Day and 10/11 Gala Day.



The 3 week finals series for the winter competition went smoothly fixtures wise. For the Spring Competition we had to move the 9/10 Division 2 competition to Loftberg courts as several courts were unavailable due to the installation of the lights. We are trialing rotating fixtures for Monday nights, ladies division 4, 5 & 6. This was to avoid one division having to play the 8.40pm timeslot which was not popular.

6.8 Grading Report:

Winter Competition:

This season 328 teams competed from Net Set Go through to A grade.

- Senior teams: 69
- Junior teams: 179 (10 years – Cadets)
- Net Set Go: 81 (7-9 years)

There was a decrease in team numbers in Opens, 10 years, 12 Years & NSG this year. However, team numbers were slightly up in 9 years, 11 years, Inters & Cadets.

During days 4 and 5, the Grading Committee watched/assessed then regraded 27 teams based on the results up to and including day 5. Most teams that were regraded were in 9 years as we didn't have the 9 year round robin at the beginning of the season due to bad weather.

Spring Competition:

The Spring Competition is currently underway with 109 teams competing from 9/10 years through to Ladies Comp and Senior Mixed. Team numbers are down on 2018 figures. The grading committee decided to not have competitions in ladies' divisions 1, 3 and 9 due to lack on team numbers.

- Ladies Comp – 44 teams, Senior Mixed Comp – 22 teams, Cadet Mixed – 9 teams, Inter Mixed – 10 teams, 11/12 Comp – 10 teams and 9/10 Comp – 14 teams.

Over the last few years the Spring Competition has been extremely difficult to grade due to teams stating they could only play at a certain time and night rather than where they should be graded. This year we are trialing a rotating timeslot in the Ladies Competition (grades 2, 4, 5 & 6) At this stage it seems to be working well, however I will request feedback from clubs and advise.

Special thanks to the wonderful 2019 Committee: Larissa Daniels, Belinda Kelly, Jen Maneschi, Jill Martin and Fiona Rondeau. I would also like to thank Loraine Unicomb, Tanya Sinclair, Katie Bonjer, Tatjana Domazet, Devi Ramakrishnan, Brenda Williams, David Funk and Jo-Anne Perry for their continued support during the season.

6.9 Ground's Report:

Thank you to all volunteers who assisted with the grounds during 2019. Special thanks go to the members of the Grounds Committee who work hard to ensure that everything runs smoothly, with mention to Stewart who joined us this year. Equipment-wise, the main purchases during 2019 were a new BBQ, a new portable PA system, and replacement parts for the rep tents which needed repair.

Around the grounds there has been some significant work this year:

6.10 Member Protection Report:

Overview of recent policy updates

In December 2018, Netball NSW adopted a revised set of Member Protection and associated policies, which came into effect in January 2019.

As part of the updates, the existing Member Protection Policy has been reorganized and revised into three distinct policies:

- (i) the Member Protection Policy,
- (ii) the Disciplinary Policy and (iii) the Grievance and Dispute Resolution Policy.

The Member Protection Policy seeks to ensure that every person involved in netball is treated with respect and dignity, and is protected from discrimination, harassment and abuse and other inappropriate and unacceptable behaviour. The Member Protection Policy has broad application – the Member Protection Policy applies to parents, guardians, spectators, sponsors and other persons to the fullest extent possible. All individuals bound by the Member Protection Policy are responsible for (i) complying with the standards of behaviour set out under the Member Protection Policy, (ii) placing the safety and welfare of children above all other considerations, (iii) complying with any decisions and/or disciplinary measures imposed under the Member Protection Policy and (iv) cooperating to provide a netball environment free of discrimination, child abuse, bullying, sexual harassment and victimization. *Attachment B* to the Member Protection Policy now provides forms for documenting both informal and formal complaints under the Member Protection Policy and includes detailed Complaint Handling Procedures. Forms are available at the complex at Canoon and can also be downloaded from [library policies link](#).

The Disciplinary Policy provides a formal framework for addressing “on court” offences. The Disciplinary Policy imposes automatic 1 and 2 game suspensions for certain “on court” offences that apply mandatorily, without the need for any Disciplinary Tribunal proceeding. Where a player has been ordered off for the remainder of the game by an umpire, the umpire must report the ordering-off by completing an Incident Report in the form included as Appendix C to the Disciplinary Policy as soon as possible after the game. A player who has been ordered off for the remainder of the game for an alleged level 1 offence will receive an automatic 1 game suspension from all games in the competition in which the ordering off occurred and no Disciplinary Tribunal will occur. A player who has been ordered off for the remainder of the game for an alleged level 2 offence will receive an automatic 2 game suspension from all games in the competition in which the ordering off occurred and no Disciplinary Tribunal will occur. Where the player has been ordered off for an alleged level 3, 4 or 5 offence, or for a subsequent level 2 offence, the matter will proceed directly to a Disciplinary Tribunal, and the player will be suspended until a decision has been made by the Disciplinary Tribunal.

The Grievance and Dispute Resolution Policy covers grievances and disputes as between members (and/or with clubs and associations). Under the Grievance and Dispute Resolution Policy, member to member grievances and disputes will generally be resolved by mediation.

As a general matter, all issues or potential issues should be raised and first considered at club level, where practicable and appropriate. Each club should appoint a Member Protection Information Officer, whose role it is;



- (6) to provide input and guidance as to the applicability and relevance of the Member Protection Policy to alleged issues and incidents raised at the lower informal level and
- (ii) to provide information in relation to the rights, responsibilities and options available to an individual that may be considering making a complaint.

Critical in ensuring the safety for participants that is fundamentally the core priority under the Member Protection Policy is that members feel comfortable approaching the MPIO and see the MPIO as impartial and not conflicted. If complaints are handled at club level, the MPIO should not be the officer advising of, or administering, any sanctions. If a complaint is raised at club level, it is also vital that confidentiality be maintained as between participants in the process. Any complaint should not be the subject of an executive meeting or broad discussion among executives.

2018 – 2019 incident report

During the year, there were three incidents of note. Two of these incidents were able to be resolved by KNA without the need for Hearing Officer consideration or a Hearing Tribunal. In the context of a third complex situation, KNA supported the relevant club in obtaining, and acting upon, advice from Netball NSW.

Particularly in view of the recent revisions to the Member Protection and associated policies, these incidents highlight that each of us – players, umpires, coaches, supporters and administrators – must ensure that

- (6) the safety and welfare of children is 16atronized16 above all other considerations,
- (ii) all those involved in netball activities are treated with dignity and respect and
- (iii) the game we love takes place in a safe and supportive environment and is played, officiated and administered in accordance with the spirit of the game.

6.12 Night Competition/Spring Report:

This year's competition started on Monday, 9th of September for 3 weeks, followed by a 2-week school holiday break.

This year's competition attracted a lower number of teams than last year (down from 119 to 110) across all but



Cadets Divisions. The most significant drop was in the Mixed Competition (down 3 teams) followed by 2 less teams in Ladies, Inters and Juniors Divisions. This could be partially explained by the increase in number of indoor netball competitions available to netball players during this period.

Given the commencement of the floodlighting capital works project at the Canoon Road Complex and the availability of only 8 courts for the 2019 Spring competition, one of the Junior Divisions had to be relocated to the Loftberg courts. This year, a decision was made not to open the canteen based on it being inequitable at Canoon Road Complex. The Jnr spring competition for these 2 divisions (11/12 and 9/10 Div 1) has been running smoothly with the assistance of our comp supervisor, Tina Tritton (KP).

The Monday night competition saw the introduction of a 'rotating time slot' for these 3 divisions, which was received well by all teams although we experienced some issues with umpires getting mixed up on their time slots. The highest division in Ladies competition is Div 2 which is held on Tuesday nights and has been running well with the help of Margot Davis (KP). Another thanks goes to Helen Burns (NT) and Kathy Thompson for their assistance on Monday and Wednesday nights.

Some of the issues experienced to date with the 2019 Spring Competition were a reduction in team numbers across most divisions, down by 9.

As discussed earlier in the report, the availability of limited number of courts at the Canoon Road Complex this season due to the commencement of floodlighting capital works meant that one of the Junior Divisions had to be moved to Loftberg at 5.15 pm on Wednesday which could have created an issue with supervision (thank you Tina for stepping in).

Attempts to attract supervisors for Monday and Wednesday night on a permanent basis weren't successful. We had some issues with younger umpires that struggled to umpire games in both the Ladies and Senior Mixed Competition, despite their relevant umpiring badge levels.

We had some minor issues with lighting on court 4 and in the ladies toilets which has been rectified by Council. A request was sent to Council for some additional maintenance works (repainting of court lines and tree trimming)

Recommendation for 2020 Spring Competition

- Ensure that the Spring Comp Committee has an Umpires Convenor. If possible, the clubs should attempt to attract older, more experienced umpires for both the Ladies and Senior Mixed Competitions.
- If any competition is run at the Loftberg complex, consider introducing a Key-Safe on the building that will assist with attraction of volunteers.
- Continue with a 'rotating time slot' for the Ladies Competition.

6.14 Marketing Report:

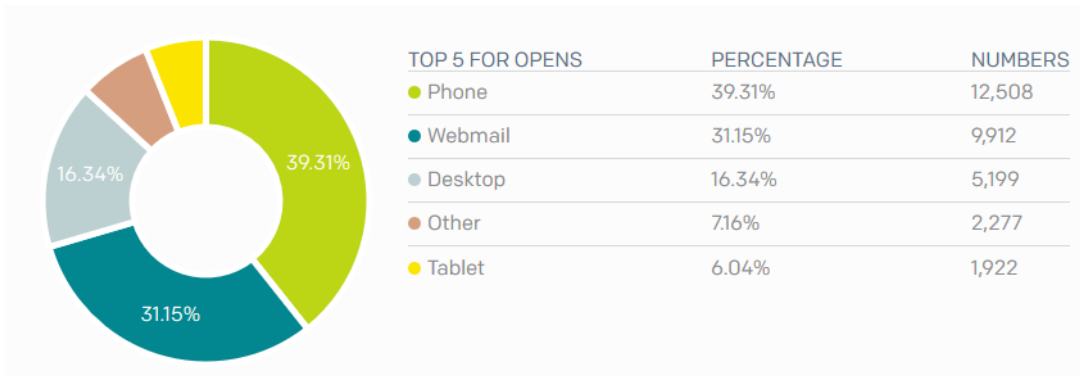


Figure 2: Below is a graph showing what people are using to view KNA e-mails:

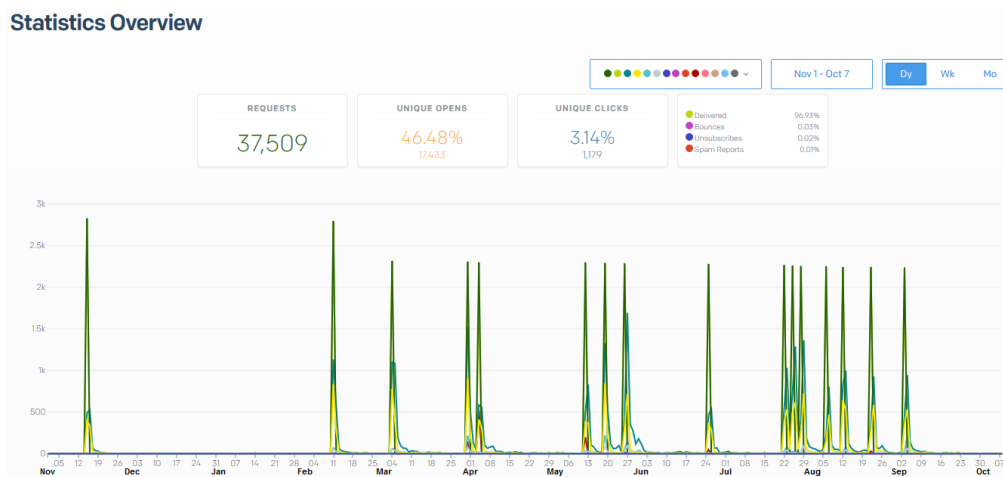
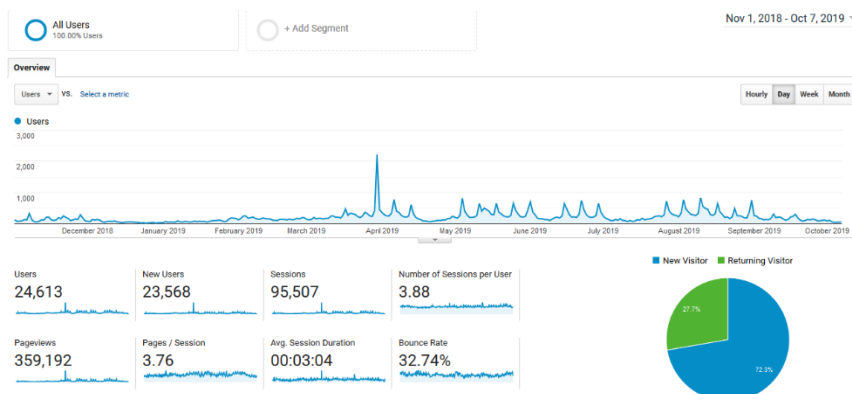


Figure 3: Google Analytics for www.kna.nsw.netball.com.au Date range: (Nov 1 2018 – Oct 7 2019) Page View: an instance of an Internet user visiting a particular page on a website

NOTICES OF MOTION TO ALLOW SMALL CLUB BORROWING

Proposed: Kissane Gray

Second: Loraine Unicomb

Proposed, to permit borrowing outside the Borrowing guidelines, for Small clubs (20 teams or less) with a "Sister club" as determined by the Grading committee.

Standard Borrowing rules would apply, including borrowing for the finals series.

It is envisaged that the club borrowing the player would provide a uniform to the borrowed player.

Process:

1. This rule will only be made available for small clubs (20 teams or less)
2. The Competition "Borrowing guidelines" will be applicable.
3. The Grading committee will vote by majority with no conflict of interest, and "highlight" Small clubs (20 teams or less) who have no borrowing capacity within their club.
4. A "Sister club" will be allocated for this purpose.
5. If the "Sister club" is not available within the borrowing guidelines the Grading Committee will designate an alternate club to assist. .
6. **All requests by the "Small Club" is to be given in writing to the Grading Committee 48 hours prior to the day of play and approved in writing.**

NOTICE OF MOTION TO CHANGE LINDEM CLUB NAME TO LINDFIELD NETBALL CLUB

Proposed: Rod Jackson

Second: Louise Woods

Lindem Netball Club hereby gives notice to Ku-Ring-Gai Netball Association (KNA) to change the name of Lindem Netball Club to Lindfield Netball Club.

Rationale for Name Change:

The decision to change the name of the club is based on the following reasons:

1. Lindem Netball was originally founded to represent the pupils of Lindfield Demonstration School, hence the name Lindem. Lindfield Demonstration School changed its name to Lindfield Public School several years ago. The name Lindem is now only associated with the Netball Club and has no recognition to any other school or organisation. The name Lindfield is representative of the suburb and local area. This enables us to represent all the schools within the local community under one (1) name - Lindfield.
2. There is overwhelming support from our members and executive to change the name of our club to Lindfield Netball Club.
3. Due to the changing demographics within our local community, it is getting more difficult to attract girls to netball. Changing the name to Lindfield will be part of our marketing within the community to provide more name recognition with the local area and hence provide more opportunities to attract players.



4. As a club, we are the southern most club within KNA based on location and closest to Northern Suburbs Netball Association, (NSNA). It is important that we have very strong name recognition within our local community to ensure we attract girls from within the local community. Particularly when girls enter high school and attend schools within the NSNA catchment area, changing associations becomes an option for them. We anticipate that changing to Lindfield Netball will provide more teams within the transition age groups to allow the club to improve our spread of teams and therefore retain these girls and attract new players.
5. Lindem Life Members and family members of deceased Life Members have been contacted in person to seek their feedback regarding the change of name. We have had unanimous support from our Life Members who believe that the change of name will be more representative of the local community.
6. The name Lindfield Netball will provide larger engagement within the local community as currently people are unaware of what the name Lindem represents.
7. The name Lindfield Netball will provide vastly improved sponsorship opportunities within the local community as we will represent the entire community, rather than a single club.
8. The change of name will also represent a change of uniform. The uniform change will be in keeping predominantly with our existing colours

We are more than willing to answer any further queries relating to the change of name.

9 courts for lights - David advised where the poles will be and our inclusion of a new PA system/speakers.

Jo-Anne advised KMC has have undertaken an extensive tender process and the company commissioned to do the job is the best quote and their preferred supplier. As this property is not KNA's, KMC must approve all works and the condition of approval for lights was that KNA would fund the project. KMC are in charge of all maintenance on their sites as we have a rental arrangement.

Spring comp: We hope to be operational for Spring comp with one night comp usage ensuring participants are contained in the Canoon Road parking area and surrounds.

Works will be taking place during our Winter comp: Safety will be paramount and appropriate measures taken by KMC at all times during construction. There is also a period in school holidays that will assist access.

Treasurer's Report

KNA's finances are operating a little below budget year to date and this is expected to flow through to the final year figures. The below budget performance is primarily due to lower Winter competition player numbers compared to the previous financial year. This was mainly Senior and Netsetgo registrations. Some of this reduction in revenue has been offset by reduced operating costs, including reduced insurance premiums through a change in provider.

Following approval at the last SGM, KNA has paid Ku-ring-gai Council approximately \$321k and \$37k (including GST) for the provision and installation of Sports lights and a shelter at Cannon road. Both projects are planned by Council to be completed by the end of November 2019 (with the shelter anticipated to be finished by the end of August 2019).

KNA has continued to invest in our facilities including a new BBQ, and new flooring and minor works in the female change rooms.

KNA continues to support our community and North Shore United Netball, including a donation of over \$5k for the Kid's Cancer Project. This donation was raised during our recent Crazy Hair and Sock day - a fantastic effort by KNA and our members.

KNA has applied for a NSW community grant to help fund our Sports lights project at Cannon road. The awarding of any grant will be dependent upon a public vote that will commence on 15th July and close 15th August 2019. Further details will be sent to you following our SGM.

The KNA Executive will shortly be having a number of Strategy meetings to develop a 5 year plan and this will include how we will further invest to improve our amenities to all of our members.

Grading Report

This season there are 329 teams in total, as follows:

Senior Teams – 69

Junior Teams – 179 (10 Years – Cadets)

NSG Teams – 81 (9 Years and Lofberg)

Overall, we are down 10 teams on 2018 Winter Competition.

The grading committee received several grading disputes after preliminary grading was issued to clubs in March. All of these were addressed and several changes were made.

This year we did not have the 9 Year Round Robin (due to bad weather) and therefore could not grade this age group. The grading committee paper graded this division, based on information received from clubs.

NSG Lofberg: "Grading" teams at Lofberg was extremely challenging as there are only 4 courts and with 15 teams requesting to play at the same time and grade this is simply not possible.

We ask all clubs/teams to submit 3 options/times they can play at Lofberg but, in most cases we do not receive this information. Many teams need to play at a certain time due to other team commitments and coaches' availability. Clubs must confirm with teams prior to registering, 3 available times preferably in appropriate age groups.

Regrading was completed after day 5 (11th May) with a total of 27 teams moving grades.

Grounds Convenor's Report

Grounds has been running well this year, with no significant problems to report.

Around the courts, we are seeing various works which will help to improve our facilities:

- The final piece in the car park resurfacing has been completed.
- A lock-up cage has been installed to hold the bins out of the way of vandals.



- A permanent shelter is on the way for the physio area. This is scheduled to be installed between 29/7/19 and 8/8/19 (2 weeks).
- Planning is under way to install the lights. Installation is due to occur between 9/9/19 and 14/11/19 (10 weeks).

Thanks to everyone who is helping with Grounds during 2019. As always, if you have any suggestions for improvement please don't hesitate to contact me.

Senior Registrar Report

I have been very grateful for the club representatives support on Saturdays at our ground's complex. This not only assisted me to do other things but also gave the club representatives an opportunity to ask 1 on 1 questions regarding registrations or association procedures. The time also gave them an insight into what goes on behind those complex shutters. We are a friendly bunch.

One of the most sort after questions, thus far, was about the uniform variations. Can my team wear warm clothing under their uniform? The general answer is no, there should be no variation from your club registered uniform. However, as we have done in the past, NSG members to the age of 9 are the exception. We understand that little bodies do not react well to the early morning chills that this winter has sprung quickly upon us. Your club registrar may request long or short sleeve t-shirts and leggings to be worn under 9 and under uniforms. The stipulation is they must all be the 1 colour, no motifs and if 1 member wears it on the day the whole team must be wearing it as well. This year we have extended the tops only variation, under the uniform, to the 10-year teams. Again, all the same colours no motifs, but no leggings. These rules can all be clarified through your registrar. If there are any queries, your club registrar should contact me.

We are now over the halfway mark of the competition, with registrations still coming in for the winter season. Do not forget, if you are registering players for finals, whether it be new players or borrowed, the last day of registrations is 24th July 2019. There will be no exceptions after this date.

If you are borrowing players for finals, ensure they sign on the score sheet correctly. If information is incorrectly noted or left off, your borrowed player will be left off as a qualifying member. All players MUST have played 3 games, during the year, to qualify for finals.

27th July is Short Grades Day. If you are a grade with 6 teams, you will be playing 2 different teams on this day. Please ensure you check the website for your court numbers.

We are pleased to announce, this year, a night comp convenor has registered for the 2019 season. A big welcome to Devi from the St Ives Club. Preparations by committee members will commence soon to ensure that all the details for night comp 2019 are available early.
