Jo-Anne presented the fees variation to the forum. The meeting agreed that we will maintain fees in majority for 2020 predominantly Juniors with a small increase for Seniors but we may have to have a loss in this area this year to the extent of possibly \$30000 based on registrations. KNA will also use to promote our sport for the 2020 registrations. The Executive and Club Presidents Forum advised they were concerned about the decrease in NSG memberships and the loss to other sports.

David provided overview of changes underway and works on our sites

Jo-Anne noted that Ku-ring-gai council has not contributed to Lights and shelter upgrades at Canoon Rd and this has been fully funded by KNA and our \$200,000 grant receipt from the NSW Government which will significantly assist us with future upgrades to our site. Lights are well underway, the Physio shelter has been installed, we are pursuing a new shelter between courts 5-8. Lights should be operational by January 2020 and ready for training. Only one night of competition is allowed during the winter season. Lights will predominantly be used for training purposes

Nathan: proposal to replace our current complex facilities is in process, however in the longer term this will occur. Noted may be able to use Section 94 Council provisions.
