- 4. **NSG Orientation Day and Junior Gala Day** all participating clubs to assist and will be advised of their roster in due course (Grounds convenor to allocate in liaison with Executive liaison.
- 5. 9 year competition (Canoon) rules
  - a) NSG Rotation policy will apply for the first half of the season and will be monitored. Clubs must keep a good record of rotations for random inspection on the day and it must be up to date. It is important to remember that NSG is a development product not a competition. KNA will revert in the second half to coaches placement but only on the basis that clubs have ensured appropriate rotations took place to Round 7.
- 6. NSG Skills sessions. Volunteers required. This will not proceed unless we get volunteers.
- 7. **Lofberg Grounds procedures**: Procedures will continue as per general status quo. Clubs will be advised of their rosters from Lofberg Grounds committee
- 8. NSG Club representation:

Clubs must provide a minimum of one representative for the daily operations of Lofberg Road and Canoon Road (Orientation/and Jnr. Gala Day/Competition forum) and preferably the NSG Convenor for 2021 for players 6-9 years. It is compulsory for all clubs participating at Lofberg Road, (which is self managed), to provide a delegate/volunteer on the NSG Committee for the season to ensure the efficient management of the competition

9. Following were nominated by clubs for NSG Operations 2021 & NSG Club participation:-

Lofberg: Appointment of sub-committee (all participating clubs must provide one delegate). Roles are small and shared.

- a. NSG Committee (3)
- b. Grounds: All clubs share this role
- c. Umpires committee (3)
- d. KNA community Liaison (1)

- Lindfield NSG Committee Orientation and Gala Day and organising the score sheets with Killara.
- West Pymble and Sacred Heart NSG Sub committee assist with Orientation and Gala days

<u>Umpires Convenor</u>: Kissing Point will talk to their NSG person.

- **Sub-committee:** Sacred Heart, Corpus Christie and North Turramurra will assist **COMMUNITY LIAISON: Wahroonga** – Community Liaison, Andrew Larratt (Lofberg)
