- d) R. Havrlant raised the issue of lack of volunteers and asked Clubs to help get some new blood into the unfilled KNA positions (listed below). There are some within Clubs who could now step up into KNA roles. Bigger clubs could help. Jo Perry advised More hands make light work and we are happy to train you. Many have been there for a long time and it's essential for the growth of our sport
- e) M. Flarey raised the issue of player/spectator behaviour. He informed the meeting that an email has been drafted in consultation with Umpires and Executive which will be sent via KNA to all clubs for more emphasis on our expectations within our Code of Behaviour
- f) Spring Comp needs more helpers. The Executive declined the application submitted by the Spring Comp convenor for financial assistance for the Spring Comp positions, as it leads to many more positions needing financial assistance and considered Financially unsustainable. In saying that the Spring Comp convenor has highlighted on many occasions the lack of assistance provided and clubs must take ownership to ensure the long term viability of this successful competition. Instead, Spring Comp should be run like Saturday Lofberg is with club participation mandatory and a sub committee chair to do Grounds rosters to be appointed by KNA with clubs supporting the competition. Clubs must ensure the success of our comp by offering volunteers
- g) The Chair informed the meeting that the Executive is in discussions with Councillors regarding:
 - i) removing the age provision of our MOU with KMC.
 - ii) Lighting into Canoon Road Carpark, and
 - iii) Resurfacing Lofberg courts.

Junior Rep Selectors x 5 for each applicable age group

No nominees were received. This is an elected panel. Stuart Moore will have discussions with existing panel to seek their support for 2021/2 season. Clubs are invited to submit any further members nominations for consideration to Executive.

Elected panel: Note the Junior Rep Selection Committee shall consist of: Five (5) separate selection panels being one (1) for each applicable age group. Each selection panel will comprise four (4) members being one (1) elected Junior Selector, one (1) appointed Junior Selector, one Junior Representative Coach and the Junior Rep Selection Convenor. No member of the Junior Rep Selection Committee will be eligible to be a member of the Rep Appointments Panel.

After the election for the one elected Junior Selector for each selection panel is completed, another vote will be taken for 2 Junior Reserve Selectors.
