## TREASURER:

- Update provided on Profit & Loss and Balance sheet.
- Nick suggested BBQ maybe look at increasing price and changing up the offering, i.e. hamburger/rissole with lettuce/tomato/cheese for 2020.
- Agreement that we do need to look at giving our members improved facilities, this is long overdue. How we will fund this.

#### **GENERAL BUSINESS:**

- 1. Proposal for new Clubhouse at Canoon Road Nathan Tilbury, Dugald (Architect) and David Funk have been working on this. Presentation of preliminary plans by David Funk and Dugald Mackenzie.
  - Dugald volunteered to draw up plans for KNA. One key issue where do we store things. We cannot have ramp access to basement level, too restrictive and would eat up too much room to make it compliant. There would be a lift access. Could have a tunnel. Need to have a store room for Council use – storage of tennis nets etc. Preliminary feedback look at increasing size of change rooms, toilets and disable access. Kitchenette for upstairs.
  - Dugald would like us to give him some direction and feedback now as to what facilities/room layout etc we would ideally want to have.

- Budget approximately \$3,000 psm. We need to have space to grow, consider what we would be utilising in 10-20 years time. Dugald mentioned that some community clubs are now looking at use of spaces during the week by paid renter, i.e. F45 setting up in Rugby Clubs need storage for mats.
- We have to allow for external accessible toilets for Tennis/community use. Clean-up sink in main area off canteen for use by coffee van and BBQ.
- David provided an update on lights installation Council have allocated a job number. Quarterly review undertaken by Council in April to allocate jobs for the next quarter. Has to be on the main budget and the operational budget. <u>We</u> <u>need to keep on the Council</u>. We have paid out substantial funds and given our members an undertaking as to installation. Suggest we approach Nathan again to ask if he would keep in close contact with KMC. If we need applications done Dugald would be good resource.
- 2. Sponsorship status Jason. Lorna Jane pop up stall donation of \$150 vouchers not proceeding. Nil return. Sponsors day this Saturday.
- All Abilities Carnival Jo-Anne and Loraine. 16<sup>th</sup> June set up Try Bookings link. Loraine has been approached to set this up. Will need Grounds Duty, Canteen and BBQ assistance.
- 4. Grants (KMC and/or Government) for lights/works Bart and Jason to update KMC Grant we don't believe we will be able to apply because the funds have been paid already. Need to look at other Grant opportunities as well. Jo-Anne is talking to Council to find out if we can apply.
- 5. Marketing we really need to look at targeting NSG players. Need to be careful about super clubs forming. Look at Clubs and how many teams each have. Recommend we have a strategy meeting/workshop to look at our forward strategy as an Association, to include marketing, funding. Understand the basics first and then put to the Presidents for their input. Perhaps ask them for a one page vision for their Clubs and the Association target say 5 strategic questions to put to them. Also maybe put into the strategy how we guide/promote development of grass roots players, i.e. do we want to be encouraging superstar players/teams or fun and enjoyment for the masses, focus on natural ability and if coachable.
- 6. NSG/Junior Gala Day (helpers) Ros and Loraine. NSG Gala Day trying to get Michelle involved, meeting scheduled for this Saturday 4<sup>th</sup> May in the morning with Michelle, Ros, Jo-Anne to put plans in place for her and NSG Committee, lay the expectations. Take on the running of the day. Lee will get all the accounts and registrations. Fixtures will be done by Katie.
- Competition regrade protocol Loraine. Kissane has already flagged a few teams that will need to be looked at. Even with the guidelines no guarantee that team will be moved, also have to look at number of teams in the grade and/or mitigating circumstances.
